- I will not assign my Korat(s) to any research institution, hospital or laboratory testing facility for any type of experiments.
- All Korats born as a result of mating this Korat will be sold or given as per terms of this agreement/pledge.

As a responsible breeder, it is noted that:

- In the rare event that the new owners do not fulfil the obligations under this sales agreement, the breeders may in their absolute discretion elect to terminate the agreement.
- In the event that the breeders terminate this agreement, the new owners shall forfeit the cat or kitten, together with the purchase price paid under this agreement. The new owners shall within seven days of notice of termination return the cat or kitten to the breeders/sellers.
- In the event that within a reasonable period after purchase the Korat is deemed to be suffering from any health problems and/or dies from causes other than misadventure, the new owners shall immediately inform the breeders. Subject to the veterinarian's report the breeders may at their discretion replace the Korat or refund the purchase price to the new owners.
